Courts must consider temporary custody arrangements, modified parenting plans, and alternative communication methods to preserve the parent-child bond during extended absences."

The Servicemembers Civil Relief Act provides certain protections for deployed military personnel, allowing them to request stays in divorce proceedings when military duties prevent court participation. However, these protections can extend case timelines significantly, creating additional stress for families already navigating separation.

Parenting plans for military families often incorporate provisions for virtual visitation, adjusted holiday schedules based on deployment rotations, and delegation of decision-making authority during absences. The firm explains that successful custody arrangements must account for the unpredictability of military service while maintaining stability for children.

Geographic challenges compound these complexities when service members receive permanent change of station orders during ongoing proceedings. Relocation can trigger jurisdictional questions and require modifications to existing custody arrangements. The firm's earlier announcement regarding military divorce complexities emphasized that these cases often involve multiple state jurisdictions, adding layers of legal consideration.

Temporary custody arrangements during deployment require careful documentation to protect parental rights upon return from service. Courts typically view deployment as a temporary circumstance that should not permanently alter custody rights, yet extended absences can affect the practical implementation of shared parenting responsibilities.
