The company recognizes that repairing today's vehicles often extends beyond restoring body panels and paint, requiring careful attention to the electronic safety systems integrated throughout the vehicle.

"Vehicle technology continues to evolve, and collision repair has evolved with it," said a representative of Wilder Auto Body. "Advanced driver assistance systems are designed to support drivers on the road, and

proper calibration is an important part of the repair process whenever manufacturer procedures indicate it is required."

According to the company, Advanced Driver Assistance Systems, commonly referred to as ADAS, include a variety of technologies designed to assist drivers during everyday operation. Depending on the vehicle, these features may include forward collision warning, automatic emergency braking, lane departure warning, lane keeping assistance, adaptive cruise control, blind spot monitoring, rear cross-traffic alert, parking assistance systems, and surround-view camera systems.

Many of these technologies rely on cameras, radar sensors, ultrasonic sensors, and other electronic components mounted behind windshields, bumpers, mirrors, grilles, or other body panels. Because these components are closely integrated into the vehicle's structure, even relatively minor collisions or certain repair procedures may affect their positioning. Wilder Auto Body explains that manufacturer-recommended calibration procedures help verify these systems operate within the specifications established by the vehicle manufacturer.

The company notes that ADAS calibration is often considered during repairs involving bumper replacement, windshield replacement, suspension repairs, structural repairs, wheel alignment, or other collision-related work that could influence sensor positioning. Identifying these requirements begins with a detailed vehicle inspection and reviewing manufacturer repair information before repairs proceed.

Modern collision repair requires much more than replacing damaged parts. Wilder Auto Body continues investing in specialized calibration equipment and technician education to support the repair requirements of today's vehicles. As manufacturers introduce new safety technologies each year, ongoing training helps technicians remain current with evolving repair procedures and calibration methods.

The company also explains that calibration procedures vary between manufacturers and even between different vehicle models from the same manufacturer. Some vehicles require static calibration using specialized targets and measuring equipment inside the repair facility, while others may require dynamic calibration procedures performed under controlled driving conditions. Following manufacturer-informed repair procedures helps ensure the appropriate calibration process is performed when required.

Customer education remains an important part of the repair experience. Many drivers are unfamiliar with ADAS technology until their vehicle requires repairs after an accident. Wilder Auto Body works to explain why calibration may be recommended, how these systems support vehicle operation, and why following manufacturer repair procedures is an important part of restoring modern vehicles after qualifying repairs.

The company emphasizes that ADAS calibration is not performed solely after major collisions. Depending on

the manufacturer, relatively minor impacts or component replacements may also require calibration procedures. Reviewing repair requirements for each individual vehicle allows technicians to determine which procedures are appropriate based on the repairs being performed.

As more vehicles incorporate cameras, radar units, and electronic safety technologies, repair facilities continue adapting to changing industry standards.
